Judging

A panel of esteemed judges who will be officially announced in the weeks leading up to the show will be crowning the 2017 RSR Queen! Contestants will be individually presented in front of the panel for judging. The top 10 (TEN) finalists will be asked to return on stage for the announcement of the top 3 (THREE), the awards being presented and 2017 Ms. Roadshow Revival being crowned. Time Line of the Event

12:00am – Call Time. Please check in at the Pin Up Registration Booth no later than 12:15pm – Assemble for the Group Shot/Final Touches 12:30pm – Group Shot led by Carlos Avila Photography. Please note that you will forfeit your position in the group photo should you not be there on time.

Stage times, break time and official judging time will be announced at a later date when the producer has set the schedules for the bands. (Initial after reading _____)

Contest Rules and Guidelines

• Contestants MUST be at least 18 years of age. • Entry Fee for each contestant will be \$50.00 unless sponsored. The CASH prizes available to the winners of the contest are \$200.00 (1st place), \$100.00 (2nd place), \$50 (3rd place). • Winner will be determined by a panel of photographer judges, NOT public voting. • Each lady will check in & be a part of the group shot promptly at 12:00. Have fun. • Throughout the show, each contestant will be asked to enter the stage in numerical order, state her stage name and say something about herself. • Vintage props and accessories are highly encouraged however please no umbrellas in group shot. • Ladies should be dressed in era-appropriate, pin-up attire. All dresses must extend to the tips of your fingers fully extended. No western wear (Classy - NOT Trashy) • No nudity, flashing, pasties, lingerie or swimsuits. Please follow the dress code provided above. • No Changing of Outfits. (A change of shoes can be used if needed) • All contestants are responsible for providing for their own hair, makeup and styling. This is your chance to be unique and creative! • A professionally taken image for use to promote you as the contestant must be submitted via email to debbie@roadshowrevival.com. It may be from a tight headshot to a full body but isolated such that only you are seen (plus relevant props). Image must be current. It can be cute and sassy, cheesecake, classic pin-up but as always, the classier the better. Inappropriate poses will not be accepted. Please submit the image in the form of a JPG or PSD (no PDF's will be accepted) sized as 4x5/4x6 @300 dpi. It is up to the contestant to provide an adequate image in good taste. Logos of the photographer and photo credits are encouraged. • Drug use and excessive drinking resulting in being drunk is prohibited by pageant contestants. Any contestant found to be extremely intoxicated/disruptive will be asked to leave the competition/event as this is a family event. • Should a contestant be dismissed from the pageant for any reason, your entry fee will NOT be refunded nor will your sponsor's
